There have been a couple of questions that have arisen in connection with this Request for Proposals. For clarification, see the attached copy of the original RFP with notations / addendums marked on the document.

REQUEST FOR PROPOSALS

DIGITAL ARTWORK FOR INTERPRETIVE DISPLAYS HISTORIC WATER STREET PROJECT CITY OF SAULT STE. MARIE, MICHIGAN

The City of Sault Ste. Marie is requesting proposals for the preparation of digital artwork for interpretive displays along Water Street in Sault Ste. Marie as part of a comprehensive redesign and reconstruction of this historic street.

This project involves the preparation of the graphics in a final form so that the production facility that will be selected by the City will be able to take the final artwork for each panel, and integrate it into final high pressure laminates for the interpretive signs.

Description

a. NUMBER OF PANELS: There will be a total of 32 separate panels in this project.

- . 24 panels will have exterior dimensions of 18" x 30"
- . 6 panels will have exterior dimensions of 20" x 36"
- . 2 panels will have exterior dimensions of 16" x 20"

files may be in (tif) format

b. CONTENT AND SUPPLIED INFORMATION: Each panel will likely include one or more digital photos or maps, as well as the panel headline and supporting text and captions. Each panel will also include a QR Code linking to a City website. The information will be provided to the contractor in both text files (likely Word) and digital photographic files (png) at 300 lines per inch. The information will be supplied in digital format with graphics and text clearly linked to each other with, in some cases, rough sketches of possible layouts for general reference.

c. NATURE OF THE WORK. Using the supplied information, the contractor will be expected to prepare both draft and final artwork versions of each panel.

. Draft copies of the proposed panel artwork will be supplied to the City for review prior to final packaging. Single copy full scale paper versions of each panel will be sufficient for review and comment.

the full scale may be in black and white with reduced 8 1/2 x 11" in color for review

. Final Artwork will be prepared to meet the Artwork Guidelines attached.

d. SUBMITTAL TO PRODUCTION FACILITY: The contractor will supply to the City-selected production facility the final art work in the form required by the production facility. (The Art Guidelines noted above indicated common requirements typically required by production facilities.)

Please provide company and individual background as well as any samples and references for similar work to demonstrate the required expertise to accomplish the project.

Provide a suggested work plan and timetable that meets the time schedule noted above.

Provide a cost per panel.

Proposal Evaluation Criteria

Proposal will be evaluated on the basis of the following:

1. Firm or individual's background and expertise
2. Ability to meet various time constraints.
3. Proposal cost
